Mid-year Monitoring of the School Improvement Process


- Remember that this is a team process.

- Check that you have hired highly qualified teachers and that all positions are filled.
- Check that relevant professional development has been offered and is scheduled for the remainder of the year.
- Schedule an EESAC meeting between January 23-30, 2009, to review and approve the mid-year report.


